### Sample Boudoir Photography Contract Template (must edit to your own needs)

#### **BOUDOIR CLIENT RELEASE FORM**

I, (hereafter "Client") do hereby authorize Melissa McClure Photography, Photographer's legal representatives, assigns, and those acting under Photographer's permission and on Photographer's authority (as in the case of photographers attending a "group shoot") to copyright, publish, and use in conjunction with self-promotion in all forms and media and manners — including but not limited to Boudoir website, blog, Facebook fan page. Client is able to specify exactly how they want the images used, if at all. Photos will not be posted without client permission.

Client hereby affirms that they are above the age 18 and that Client is fully able to contract in his/her own name without breach of any prior agreement or applicable law. If a minor under the age of 18, then the parent or legal guardian shall sign this release as well.

A retainer fee is collected at the time of booking and needed to reserve the date. If the client cancels at any time after the booking is complete, the retainer is forfeited to the photographer.

I have read the above authorization and release prior to its execution and I am fully familiar with and agree to the contents thereof.

#### COMMERCIAL USE LICENSE AGREEMENT

Please read the end user license agreement found herein, to ensure legal use of images from MELISSA MCCLURE PHOTOGRAPHY, referred to as MMP.

#### License Agreement

This license agreement ("Agreement") is between "Licensee" and MMP and governs your use of Licensor's Images.

MMP retains all rights, license, copyright, title and ownership of the Image(s).

#### A. License

Subject to the terms of this license agreement, MMP grants Licensee a worldwide, perpetual, non-transferable, non-exclusive right to reproduce, transmit and display, in whole or in part, MMP Royalty Free Image(s) (whether available as part of a DVD collection of images or downloaded as a single image) an unlimited number of times, in any and all media for the purposes described below. MMP represents that it has the right to grant the license herein. All other rights to the Image(s), DVD and accompanying materials (if applicable), including without limitation, copyright and all other rights, are retained by MMP.

#### B. Permitted Commercial Uses

1. Any advertising and promotional projects, including printed materials, product packaging, presentations, film and video

presentations, commercials, catalogs, brochures, promotional greeting cards and promotional postcards (ie. Not for resale or license)

- 2. Any entertainment applications, such as books and book covers, magazines, newspapers, editorials, newsletters, and video, broadcast and theatrical presentations
- 3. Any on-line or electronic publications, including web pages
- 4. Any prints, posters (i.e. a hardcopy) and other reproductions, including those for resale; provided those products are not intended to allow the re-distribution or re-use of the Image(s)

Licensee may alter, crop, modify or adapt the Images in connection with the above permitted uses. Licensee may make a back-up copy of the Image(s) for internal back-up purposes provided MMP'S copyright and any image identifying information is retained with the file. Limited, temporary transfers of the Images are permitted to third parties integral to the creation of the final product, provided such third parties agree to abide by the terms of this agreement.

#### C. Restrictions on Use

Except as provided herein, Licensee may not:

- •Sub-license, sell, assign, convey or transfer any of its rights under this Agreement.
- •Sell, license or distribute its final product in such a way that permits Licensee's end users to extract or access the Images as a stand-alone file.
- •Incorporate the Images into a logo, trademark or service mark.
- •Use any Image in a pornographic, defamatory, libelous or otherwise illegal manner, whether directly or in context or juxtaposition with other materials.

#### D. Indemnity

Licensee agrees to indemnify and hold MMP harmless against all claims arising out of or in connection with any breach of this Agreement.

#### E. Warranties

MMP MAKES NO WARRANTIES, EXPRESS OR IMPLIED, REGARDING, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. MMP SHALL NOT BE LIABLE TO LICENSEE OR ANY OTHER PERSON OR ENTITY FOR ANY GENERAL, PUNITIVE, SPECIAL, DIRECT, INDIRECT, CONSEQUENTIAL OR INCIDENTAL DAMAGES, OR LOST PROFITS OR ANY OTHER DAMAGES, COSTS OR LOSSES ARISING OUT OF LICENSEE'S USE OF THE IMAGES, OR OTHERWISE.

Licensee may have additional rights under state law.

#### F. Severability

If one or more of the provisions contained in the Agreement is found to be invalid, illegal or unenforceable in any respect, the validity, legality and enforceability of the remaining provisions shall not be affected. Such provisions shall be reformed only to the extent to make it enforceable.

#### G. Waiver

No action of MMP, other than express written waiver, may be construed as a waiver of any provision of this Agreement.

#### H. Entire Contract

This contract contains all the terms of the license agreement and no terms or conditions may be added or deleted unless made in writing and signed by an authorized representative of both parties.
